Plant Outreach to Community, Including PCAC and Community Relations Programs

All plants were invited to share 3 highlights of their community relations (good deed) programs that serve community organizations, the city, the school district, and other categories like this. Plants provided information on how an organization applies for support from that plant, describing whether it is a formal or informal process and whether or not the plant has a set budget for commuting relations each year. The information is compiled in a separate document what will be send out to all PCAC members and attendees.

Selina Bellar, City of Pasadena's Manager for Neighborhood and Industrial Network, presented information about "Team Up to Clean Up" program that assists senior citizens, military veterans, disabled persons and low-income homeowners within the city. Chevron Phillips was a title sponsor for both 2018 and 2019.

PCAC's plan to begin the community relations discussion with a review about PCAC itself was postponed to allow time to cover the previous reports. Facilitator Diane Sheridan said that PCAC was established to create dialogue between plants and the community about plant-related issues where the community has interest or concern. Members believe plants should be assisting the community, ask them to include such occasionally information in their plant updates, and 2-3 times over the years have scheduled a report like tonight's. The presentation on PCAC's founding will be made at a future meeting.

HOST PLANT INTRODUCTION AND SAFETY MOMENT: Kinder Morgan Liquids and Kinder Morgan Export Terminal

Safety Moment: David Koetter presented information on how to identify possible credit card skimmers at gas stations.

Plant Intro: Koetter, Marlin Collins and Alex Rendon presented information about Kinder Morgan, which is the largest energy infrastructure company in the US. Kinder Morgan's Houston Hub is the world's largest integrated terminaling system whose products include refined products, chemicals, crude, ethanol, bio-fuels, fuel oil, petcoke and coal. These products can be moved by pipeline, rail, barge, ship and truck. Kinder Morgan Export Terminal loads products on ships for export and barges for domestic use. Kinder Morgan Liquids Terminal (Pasadena) stores and ships gas, oil and jet fuel for many of the refineries in the Houston Area and currently has 208 employees.
