# Industry Impacts on the Community: Jobs, Taxes, Community Relations Programs

- Instead of focusing on environmental and safety impacts from industry, this meeting will look at what are often seen as positive aspects of local industry.
- PCAC will invite a speaker from the Pasadena Economic Development Council or East Harris County Manufacturers Association to share data about the jobs associated with the petrochemical industry in Pasadena. (10-12 minutes)
- Since PCAC just had plants report in September 2019 on highlights of their community relations programs, the report from that meeting will be handed out, but there will be no presentation. (5 minutes)
- When the planning committee began discussing industry tax contributions, they found they had little factual knowledge about the industrial district agreement(s) that allow plants to forego city services and pay a fee in lieu of taxes. With a goal of obtaining facts, PCAC will invite speakers to address the following questions:
  - O What is an industrial district and what is its purpose?
  - o Where are Pasadena's industrial districts? How many are there? When did they begin?
  - What percentage of the city's acreage is covered by industrial districts? Show on a map.
  - o Are all PCAC plants located in an industrial district?
  - What local government services, if any, do plants in an industrial district receive? What services don't they receive?
  - o Who is the agreement among? Who negotiates the agreement?
  - o How often is an agreement renegotiated and readopted?
  - o How are other taxpayers affected when industry pays district fees instead of taxes?
  - What were the public concerns raised during the recent renegotiation of an industrial district agreement? How were they addressed?

**Mission:** The mission of the Pasadena Citizens' Advisory Council (PCAC) is to provide a forum that opens dialogue between citizens and industry, addresses issues of interest to both, and promotes awareness and understanding of those issues.

Purposes/Objectives: The purposes/objectives of the PCAC include but are not limited to the following:

- Industry and community will work together to educate the community about who "industry" is, their operations, and what they do for the community. Methods could include plant tours the PCAC believes useful, with question and answer sessions at plant sites. Industry should verbalize future plans well in advance so the community can digest and react to them and so that industry can work with the community to address concerns.
- Community and industry will work together to improve industry's understanding of community concerns. Concerns could relate to worker and community health and safety, risks and impacts from living near industry, emergency preparedness, economic issues, aesthetic issues, the relationship between jobs and education and the needs in Pasadena, and so on. Concerns could be identified by the PCAC itself or by a survey with sufficient focus that the PCAC could later consider how to address concerns.
- Industry will share its operating philosophy with the community so the community can assess industry performance and work with industry to bring about changes to improve the quality of life in Pasadena.
