 - Identify areas of concern that could (does not necessarily) affect a community similarly situated as Pasadena is
- Have industry teach us about operations at their plant
 - More visits to the plants
 - Allow plants more time to further explain their process and how they may affect or be interpreted by the community
- More marketing/advertising
 - We could use a better website
- What about allowing an org to speak on a topic, such as carbon capture, and have industry hear concerns we have?
 - o Get nonprofits to present their concerns about a topic and let plants hear and respond
- Collaborate with schools' parents' organizations to increase membership
- More time for interaction
